## TRUTH IN TAXATION HEARING NOTICE OF TAX INCREASE AND NOTICE OF PUBLIC HEARING ON BUDGET ADOPTION

In compliance with A.R.S. § 42-17107, the Tonto Village Domestic Water Improvement District ("TVDWID") is notifying its property taxpayers of TVDWID's intention to raise its primary property tax levy over last year's level. TVDWID is proposing to increase the primary property tax levy for FY 2020-2021 to \$35,866.80, an increase of \$1,866.00 from the FY 2019-2020 property tax levy of \$34,000.

The proposed primary tax *rate* will remain the same, at \$184.83 per \$100,000 LPV net assessed valuation, or 1.8483%. For example, the proposed tax rate will cause TVDWID's primary property taxes on a \$100,000 home to be \$184.83 (total proposed taxes). Without the proposed tax levy increase, the tax rate for FY 2020-21 would have decreased to 1.7521% and total taxes that would be owed on a \$100,000 home would have been \$175.21.

This proposed increase is exclusive of increased primary property taxes received from new construction. The increase is also exclusive of any changes that may occur from property tax levies for voter approved bonded indebtedness or budget and tax overrides.
